Title case or headline case is a style of capitalization used for rendering the titles of published works or works of art in English. When using title case, all words are capitalized, except for minor words (typically articles, short prepositions, and some conjunctions) that are not the first or last word of the title. There are different rules for which words are major, hence capitalized.

As an example, a headline might be written like this: "The Quick Brown Fox Jumps over the Lazy Dog".

The hyphen - is a punctuation mark used to join words and to separate syllables of a single word. The use of hyphens is called hyphenation.

The hyphen is sometimes confused with dashes (en dash –, em dash — and others), which are wider, or with the minus sign −, which is also wider and usually drawn a little higher to match the crossbar in the plus sign +.

As an orthographic concept, the hyphen is a single entity. In character encoding for use with computers, it is represented in Unicode by any of several characters. These include the dual-use hyphen-minus, the soft hyphen, the nonbreaking hyphen, and an unambiguous form known familiarly as the "Unicode hyphen", shown at the top of the infobox on this page. An acronym is an abbreviation formed using the initial letters of a multi-word name or phrase. Acronyms are often spelled with the initial letter of each word in all caps with no punctuation.

In English the word is used in two ways. In the narrow sense, an acronym is a sequence of letters (representing the initial letters of words in a phrase) when pronounced together as a single word; for example, NASA, NATO, or laser. In the broad sense, the term includes this kind of sequence when pronounced letter by letter (such as GDP or USA). Sources that differentiate the two often call the former acronyms and the latter initialisms or alphabetisms. However, acronym is popularly used to refer to either concept, and both senses of the term are attributed as far back as the 1940s. Dictionary and style...
